

**ENTITLEMENT OF CANTEEN FACILITIES
TO PERS OF COAST GUARDS**

1. Reference AO 2/2006/QMG.
2. Following personnel of Coast Guard are authorized all canteen facilities including liquor and APD items including four wheelers at par with serving and Ex-servicemen of three services:-
 - (a) All serving personnel of Coast Guard.
 - (b) All retired Coast Guard personnel.
 - (c) Widows of Coast Guard personnel who are in receipt of family pension.
 - (d) All CG personnel released on medical grounds, who are in receipt of disability/invalid pension and injury attributable to service.
3. All terms and conditions as applicable to the three Services will also be applicable to Coast Guard.
4. Necessary amendments to the Army Orders will be made in due course.
5. This has the approval of the competent authority.
6. You are requested to pass necessary instructions to all CSD Depots accordingly.



EXTENSION OF CANTEEN FACILITIES TO RETIRED CG PERSONNEL

1. Canteen facilities were extended to retired CG personnel vide 96019/Q/DDGCS dated 12 Apr 2002 and the formal sanction was accorded vide GOI. MOD letter No. AD/0315/CGHQ/147/DO(T)/D(N-II) dated 20 Jan 2003. (copies of letters enclosed)
2. It has been reported by lower formations that retired CG personnel are not getting liquor quota from Army canteens and they have been directed to make health permit card from excise department through DSSAB. However on approaching DSSAB, it was informed to retired CG personnel that the office of DSSAB do not have any correspondence regarding extension of canteen facilities to retired CG personnel and expressed their inability to process the matter.
3. In view of the above, it is requested that:-
 - (a) Detailed directives on the subject may be issued to all office of DSSAB's under intimation to this Headquarters.
 - (b) Office address of all DSSAB's may be forwarded to this Headquarters so as to forward a copy GOI. MOD letter quoted ibid.
4. The detailed chart stating comparison of rank structure of Coast Guard vis-à-vis Navy is placed an enclosure to this letter for onward despatch to DSSAB's.



EXTENSION OF CANTEEN FACILITIES TO
RETIRED COAST GUARD PERSONNEL

1. Reference this Dte policy letter No.96019/Q/DDGCS dated 06 Dec 2000.
2. With immediate effect all retired personnel of Coast Guard drawing pension from Defence Estimates are also entitled to canteen facilities including liquor at par with ex-servicemen of three Defence Services.
3. Liquor authorisation to retired Coast Guard personnel will be as per scales authorised to retired Naval personnel of equivalent ranks.
4. The above instructions may please be promulgated to all concerned.
