ON RECEIPT OF APPROVAL, PENSION FORMS SENT BY BUREAU TO THE ELIGIBLE PERSONNEL FOR COMPLETION AND EARLY RETURN



DULY FILLED PENSION FORMS ALONG WITH DOCUMENTS AND SERVICE BOOK RECEIVED AT BUREAU



PENSION FORMS VERIFIED WITH OFFICE RECORDS HELD WITH BUREAU AND PENSION CLAIM PREPARED AT BUREAU



PENSION CLAIM (WITHOUT COMMUTATION OF PENSION) SENT TO PCDA (NAVY), MUMBAI FOR COUNTERSIGNATURE AND ONWARD SUBMISSION TO PCDA (PENSION), ALLAHABAD BY REPRESENTATIVE OF BUREAU FOR SANCTION OF PENSION AND ISSUE OF PPO



ON RECEIPT OF PENSION PAYMENT ORDER AT BUREAU AFTER 4-6 MONTHS, THE COPY OF ORIGINAL PPO IS BEING SENT TO LINK BANK FOR RELEASE OF PENSION/ DCRG THROUGH PAYEE BANK UNDER INTIMATION TO PCDA (P), ALLAHABAD/ PAYING BANK. COPY OF INDIVIDUAL PPO ALONGWITH PENSION CERTIFICATE FORWARDED TO PENSIONER



AFTER SANCTION OF INVALID PENSION, THE CASE FOR COMMUTATION OF PENSION IS BEING FORWARDED TO PCDA (PENSION), ALLAHABAD THROUGH PCDA (NAVY), MUMBAI FOR SANCTION OF COMMUTATION OF PENSION



PCDA (PENSION), ALLAHABD IS BEING ARRANGED MEDICAL BOARD TO AUTHORISE MEDICAL HOSPITAL NEAREST TO PENSIONER'S RESIDENCE. ON RECEIPT OF REPORT FROM THE HOSPITAL ONLY, THE PCDA (PENSION), ALLAHABAD HAS SANCTION THE COMMUTATION OF PENSION ACCORDINGLY



ON RECEIPT OF CORR. PENSION PAYMENT ORDER OF COMMUTATION OF PENSION AT BUREAU AFTER CONSIDERABLE TIME, THE SAME IS BEING SENT TO LINK BANK FOR RELEASE OF COMMUTATION AMOUNT THROUGH PAYEE BANK TO PENSIONER UNDER INTIMATION TO PCDA (P), ALLAHABAD/PAYING BANK. COPY OF INDIVIDUAL'S CORR. PPO FORWARDED TO PENSIONER
